Program Description

The Oregon Criminal Justice Commission (CJC) is responsible for improving the efficiency and effectiveness of state and local criminal justice systems by providing a centralized and impartial forum for statewide policy development and planning. The nine member commission is charged with developing and maintaining a state criminal justice policy and comprehensive, long-range plan for a coordinated state criminal justice system that encompasses public safety, offender accountability, crime reduction and prevention and offender treatment and rehabilitation; serving as a clearinghouse for the collection, preparation, analysis and dissemination of information on the state's criminal justice system; providing technical assistance to local public safety coordinating councils (LPSCCs); and administering grants for specialty courts and Justice Reinvestment.

The commission is also responsible for maintaining the state's criminal sentencing guidelines established to create guidelines for Oregon sentencing proceedings. The sentencing guidelines are intended to remedy harm caused by criminal conduct through remedial steps to prevent or address expected future harm and ensure the security of people in person and property, and provide integrity to the system as a whole. Oregon's sentencing guidelines define misdemeanor offenses, presumptive felony convictions, and presumptive post-prison or probation supervision violations. The commission reviews state legislation that creates new crimes or modifies existing crimes, recommending guidelines for use in sentencing proceedings; and it makes modifications to the crime seriousness scale of the sentencing guidelines to reflect legislative action.

The chair of the Criminal Justice Commission is authorized to create committees within the commission as thought necessary. The chair appoints committee members from all segments of the criminal justice system that are affected by the committee's work

Program Description

The Asset Forfeiture program lawfully takes property, contraband, and conveyances used to commit or facilitate illegal conduct.

The Criminal Justice Commission (CJC) provides staff support to the Asset Forfeiture Oversight Advisory Committee (AFOAC), a ten member group appointed by the Governor, Attorney General, President of the Senate, and the Speaker of the House of Representatives. AFOAC is responsible for collecting information on all state law forfeitures; receiving reports on the use of forfeiture proceeds by public bodies; compiling detailed annual forfeiture reports; conducting studies to improve the oversight of forfeiture; and making recommendations to increase the effectiveness, fairness and efficiency of Oregon forfeiture actions. The CJC Administration program (see above) maintains the official copy of AFOAC's records.

Program Description

The Criminal Justice Commission (CJC) allocates state and federal resources statewide for comprehensive criminal justice planning and policy development. This responsibility includes public safety issue identification, system collaboration, policy development, and system planning and implementation. As the State Administering Agency (SAA) for the Edward Byrne Memorial Justice Assistance Grant (JAG), the CJC maintains responsibility for distribution, monitoring, and reporting of annual formula grants and when applicable, competitive grants.

The Edward Byrne Memorial Justice Assistance Grant (JAG) Program is the primary provider of federal criminal justice funding to state and local jurisdictions. The JAG Program provides states and units of local governments with critical funding necessary to support a range of program areas including law enforcement; prosecution and court programs; prevention and education programs; corrections and community corrections; drug treatment and enforcement; crime victim and witness initiatives; and planning, evaluation, and technology improvement programs.

Further, the CJC serves as the primary coordinating body for the acceptance, planning, and distribution of federal criminal justice funds leveraged to address the needs of the state criminal justice system. Oregon's SAA is an active member of the National Association of Drug Court Professionals (NADCP) and the National Criminal Justice Association (NCJA).

Program Description

The Oregon Knowledge Bank (OKB) is a resource for and created by the public safety community in Oregon. The OKB focuses on Oregon: its innovative policing, corrections, and community supervision programs; research conducted on criminal justice initiatives here; and public safety agency profiles. The Oregon Criminal Justice Commission (CJC) is responsible for tasks related to sharing information and encouraging the use of best practices throughout the state's criminal justice system. To do this, the CJC collaborated with stakeholders to establish the OKB which launched in 2015.

The OKB is guided by two complementary goals: The first is to become the go-to resource for criminal justice practitioners in Oregon for best and promising practices. The second goal is to encourage public safety practitioners statewide to use evidence-based practices and problem-solving methods.

While LPSCCs across the state engage in a variety of activities to improve system-wide communication and collaboration, their primary purpose is to: coordinate local criminal justice policy and planning; make recommendations to the county board of commissioners regarding the use of state and county resources to supervise local offenders; and develop and approve their county's Justice Reinvestment Grant program. County governments are required to send the commission an annual summary of the changes made in response to the recommendations of its LPSCC. In turn, the Criminal Justice Commission (CJC) is responsible to support and make recommendations for effective utilization of LPSCCs within the coordinated state criminal justice system.

Program: Statistical Analysis Center (SAC)

Program Description

The Statistical Analysis Center (SAC) provides the Governor, Legislative Assembly, criminal justice agencies, and the public with current and historical statistics, objective research, and data analysis regarding Oregon's criminal justice system. It directly supports the development of legislative fiscal impact statements regarding proposed legislation that may increase or decrease state costs for prison beds and offender supervision. SAC publishes criminal justice information, statistics and research for use by state and federal criminal justice planners, state agencies, universities, and the general public. It serves as a clearinghouse for the collection, preparation, analysis and dissemination of information on statewide sentencing practices.

With oversight by the Criminal Justice Commission (CJC), SAC operates as the state's criminal justice collection, analysis and dissemination point under the nationwide SAC program operated by the U.S. Department of Justice, Bureau of Justice Statistics. State SACs receive federal funding to carry out data collection and analysis on topics of interest to criminal justice policy and decision makers. Oregon's SAC is an active member of the Justice Research and Statistics Association (JRSA), a national nonprofit organization of state SAC directors, and other researchers and practitioners, dedicated to policy-orientated research and analysis.

The CJC's SAC uses and applies dynamic data and information from various government agencies, including the Department of State Police, Oregon Department of Corrections, Oregon Judicial Department, Oregon Youth Authority, and the Federal Bureau of Investigation.
