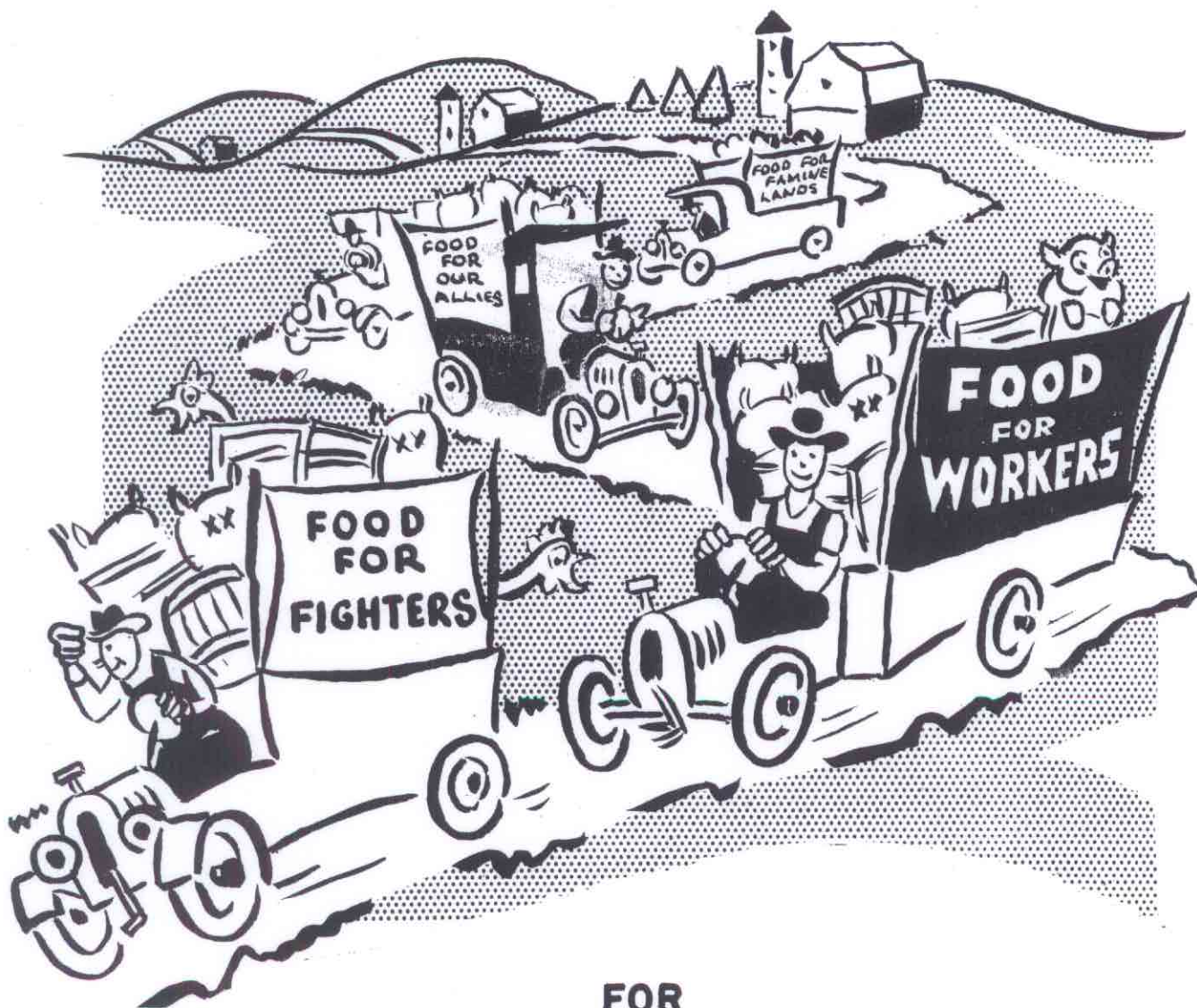

# I. The CFTC's have a WHALE of a job...



Farm products moving to market are heavy and bulky, as are the supplies farmers must buy for production use. Both rubber and rail transportation are being taxed to the limit during this period of war emergency. A large part of the transporting is done in the million and a half trucks operated by farmers or commercial haulers of farm produce and farm supplies. If these trucks break down, or if the rubber wears out, the Nation will face a desperate food shortage. To combat this danger, the Secretary of Agriculture on October 6 established a Farm Transportation Committee in every rural county.

## Your County Farm Transportation Committees:

- Chairman: Chairman of County War Board (or someone selected from County AAA Committee to serve in his place).  
Two farmer members, not AAA committeeman (representing the two principal agricultural commodities of the county).  
One member, commercial trucker of farm supplies or produce.  
One member, dealer in farm supplies.  
Alternates for each member except the chairman.

## RESPONSIBILITIES:

1. Studying rural truck traffic.
2. Developing rural truck transportation conservation programs.
3. Handling appeals for adjustments on Certificates of War Necessity.

State War Boards are also State Farm Transportation Committees and must supervise and assist County Farm Transportation Committees.

The job of the County Committees:  
TO HELP KEEP FARM TRUCKS ROLLING.

The Nation's food supply for the next year or two or three will depend largely on the skill and energy of the County Farm Transportation Committees in solving local hauling problems and setting up efficient mileage saving programs.

## 2. A good Information job is important...

### EVERY FARMER SHOULD KNOW IMMEDIATELY

- (A) If he has applied for a Certificate of War Necessity but has not received it, he can obtain an emergency gasoline ration for his truck from his local War Price and Ration Board.
- (B) If his Certificate does not allow him enough mileage to get his job done, he should, first, upon certification get an emergency ration from his local Ration Board to carry him through January 31, and, second, appeal through his County Farm Transportation Committee for an adjustment of his Certificate.

That is the emergency information job.

The main information job is to help farmers get their hauling done with less mileage. There are two parts to this job:

- (1) Inform farmers of ways in which they might save mileage.
- (2) Encourage farmers to bring their problems to the County Farm Transportation Committee and talk them over so community solutions such as pooling can be worked out on a practical basis.





### 3. Some Information Suggestions....



Transportation like farm labor is news. It should be relatively easy to secure newspaper space and radio time. A list of memos, regulations and highlight information pieces recently issued by the Department and other bureaus concerned is included on page 1. This material, which should be on file in State War Board offices, will supply interesting background facts. On the back cover are two cartoon mats which can be obtained through the usual War Board channels.

#### GET THE STORIES

Watch for specially fine, neighborly, patriotic contributions of individuals to the hauling programs.

Maybe a farmer has arranged to regularly bring his neighbors produce to town. Calculate the number of miles saved each month.

Maybe a farm woman makes a party line call to invite others to ride with her when she takes her eggs to market.

Maybe pooling loads as suggested by the Transportation Committee works well because some farmer unselfishly gives the project much of his time.

When it becomes possible to estimate the mileage reduction for a whole county, announce the mileage saving.

#### GET THE STORIES IN THE PAPERS AND ON THE AIR

Let the local people hear the stories and send them in to the State office and to Washington for State and national distribution.

#### GET PHOTOGRAPHS

Good news stories are better with photos.

Photograph pooling depots in action.

Get a picture of a pretty farmer's daughter running a flag up the windmill to flag the next farm truck going to town.

Washington is anxious to get good pictures that will help carry the farm transportation message.

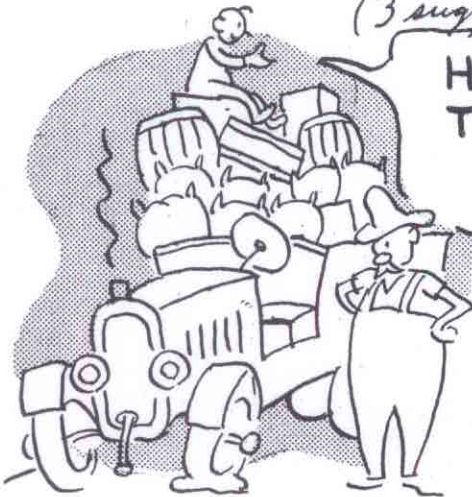

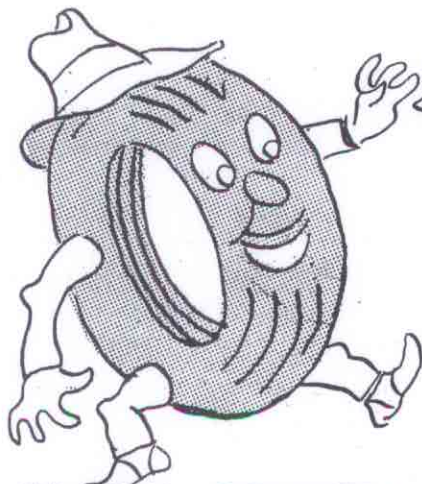


YEP, I'M HAULING FULL LOADS

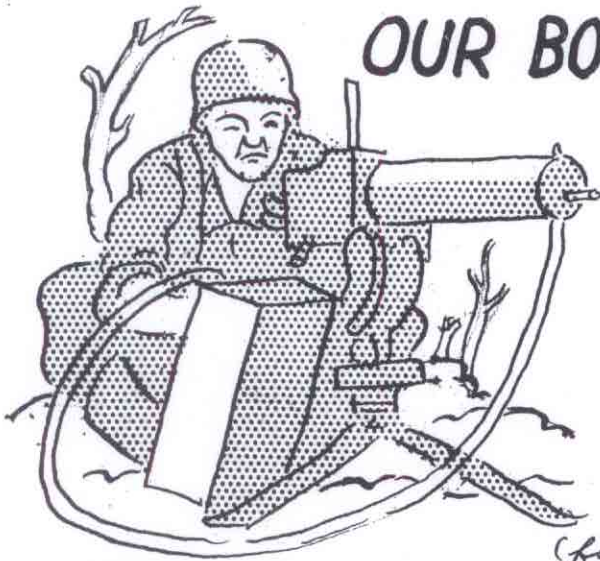

## OUR BOYS MUST HAVE FOOD!

Our soldiers in Africa, Iceland, the South Pacific and elsewhere in the world need tremendous volumes of food to keep them going. Nothing must be allowed to interfere with our production of food. Farmers must get the supplies they need, and when the food is produced it must move promptly from the farm to the places where it is most needed. Every farm truck, every rubber tire is important. Farm transportation must not break down.

## The Farm Transportation Program in a nutshell..

### TRUCKS...

Certificates of War Necessity must be carried on all commercial vehicles, including all types of farm trucks. The Office of Defense Transportation issues the Certificates. A Certificate specifies to OPA's local War Price and Ration Board the amount of gasoline to be allowed for operation of the truck.

Truck owners who have applied for Certificates but not received them may obtain an emergency ration of gasoline from their local Ration Boards.

If your Certificate does not allow enough gasoline for necessary operation, your local Ration Board will issue you an emergency ration for December and January, to give you time to appeal for an adjustment of your Certificate.

Farmers and truckers who haul only farm supplies or produce must go to their County Farm Transportation Committees to enter appeals for an adjustment of their Certificates.

### PASSENGER CARS...

The Office of Civilian Defense is developing passenger car conservation programs. Allotments beyond the basic amount of gasoline for each car will be made by the local Ration Boards only on the recommendation of the OCD, except in cases involving workers in large defense plants, which will be handled by the War Department.

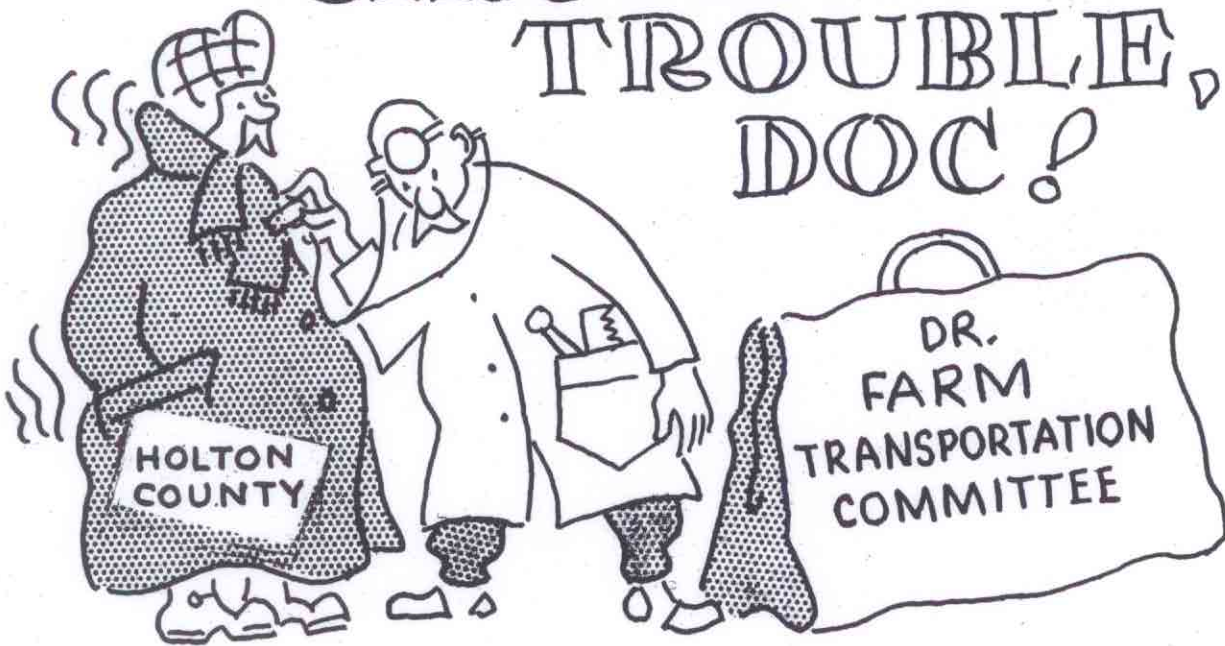
If you need an extra allotment of gasoline for a passenger car which you use primarily to transport farm supplies or produce, it might be well for you to bring the matter to the attention of your County Farm Transportation Committee.

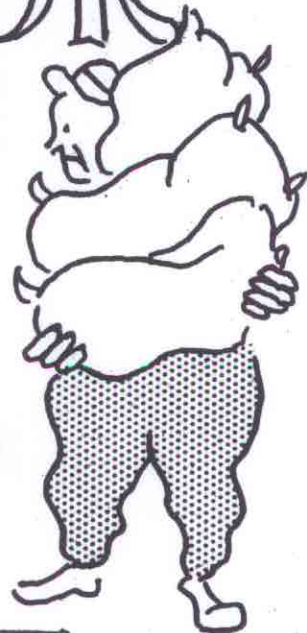
